Decomposes on heating. This produces toxic and corrosive fumes of chlorine. The solution in water is a weak base. Attacks zinc in the presence of water. This produces flammable/explosive gas (hydrogen). Dissolves violently in water with liberation of much heat. (ICSC 1184)
