The solution in water is a strong base. It reacts violently with acid and is corrosive to metals such as aluminium, tin, lead and zinc. This produces a combustible/explosive gas(hydrogen). Reacts with ammonium salts. This produces ammonia. This generates fire

hazard. Contact with moisture and water generates heat. (ICSC 0360)
(Ethanol)

The vapour mixes well with air, explosive mixtures are easily formed.

Reacts slowly with calcium hypochlorite, silver oxide and ammonia. This generates fire and explosion hazard. Reacts violently with strong oxidants such as nitric acid, silver nitrate, mercuric nitrate and magnesium perchlorate. This generates fire and explosion hazard. (ICSC 0044)
