Decomposes on heating. This produces toxic and corrosive fumes of chlorine . The solution in water is a weak base. Attacks zinc in the presence of water. This produces flammable/explosive gas (hydrogen). Dissolves violently in water with liberation of much heat. (ICSC 1184)

(Magnesium(II) nitrate,anhydride)

The substance is a strong oxidant. It reacts with combustible and reducing materials. This generates fire and explosion hazard. (ICSC 1041)
